Such a decision would be implemented from the date as mutually agreed upon between both the parties.

(c) Timely implementation of the Programme will mean the implementation of the Project with necessary support of SICS during the period.

(d) In the event of termination of this MOU, each Party shall, forthwith, cease to use the other Party's name, mark or logo, in any manner whatsoever. 3. Financial Aspects

5. FORCE MAJEURE

7. Jurisdiction & Arbitration Clause:

- On the aspects where the Articles of this MOU are silent or for cases relating to deviation from these articles, efforts would be made to resolve the issues through mutual dialogues and consultations between both the parties. If such a resolution is not possible then the unresolved disputes and differences shall be referred to arbitration in accordance with the (Indian) Arbitration and Conciliation Act, 1996, and all proceedings shall be conducted in English and a transcript in English shall be prepared. The Arbitral Panel shall comprise of three Arbitrators; one by each Party and the third Arbitrator shall be selected by the two Arbitrators selected by each Party and shall serve as the Chairman of the Arbitral panel, who's decision will be final and binding on the both the parties. The arbitration proceedings shall be held in Mumbai and the language to be used in arbitration proceedings shall be English.
- For all purposes in relation to this MOU, and specifically with regard to clause relating to Arbitration, the Courts at Mumbai alone shall have exclusive jurisdiction. No other Court shall have jurisdiction to deal with any dispute or any matter between the parties arising out of this MOU.







- 2) **Courses** means MKCL's Courses for which authorization is granted to the ALC as per specified norms for conduction under MKCL's overall co-ordination.
- 3) **Learner** means the individual registered at the ALC for the Course after full payment of the course fee and examination fee in favour of MKCL within the specified period and as per MKCL norms.

2. RESPONSIBILITIES OF MKCL

- 1) MKCL will grant authorization to the ALC to conduct its authorized courses as per norms specified from time to time. MKCL will also periodically renew the said authorization as per norms decided by it from time to time.



During the term of this MoU and for a period of One (1) year after the expiration or sooner determination of this MoU, neither Party shall, either directly or indirectly and without the prior written consent of the other Party, (i) recruit, employ, hire or engage as an employee or consultant or contractor any employee of the other Party; or (ii) solicit, induce, entice or in any way encourage any of the employees or consultants or contractors of the other Party to terminate his relationship with the other Party.

11. Indemnification

Both the Parties shall indemnify and hold each other harmless from and against any claim, loss, liability, or expense, including, but not limited to, damages, patent and trademark infringement, costs and reasonable attorneys' fees, arising out of or in connection with any acts or omissions of their agents or employees.

12. Modification

No amendment, modification or waiver of any provisions of this MoU shall be effective unless the same is in writing and signed or executed by both the Parties.
